

SAFETY INSTRUCTIONS

IF YOU HAVE ANY CONCERNS PLEASE CALL OUR OFFICE IMMEDIATELY

- A) Only compatible age groups and sizes shall play on the inflatable ride at the same time. The *maximum* number of persons, within a group, inside of an inflatable ride shall be no more than as follows: Up to 9 years old - 8 persons, 9-12 years old - 6 persons, teens - 3 persons.
- B) All riders must remove shoes, jewelry, eyeglasses and/or any other obstacles **BEFORE** entering on inflatable ride.
- C) Absolutely no "Silly String", gum, candy, food or other substances are allowed inside the inflatable ride. A \$100 Cleaning Fee will be imposed in the event that any of these objects are found inside of, or on the inflatable ride when it is picked up.
- D) To avoid back injuries all riders are prohibited from doing flips on an inflatable ride, climbing the walls inside or outside tan inflatable ride, or climbing on top of tan inflatable ride.
- E) If the delivery location requires that the equipment be transported up or down more than three steps than an additional fee will be imposed based on the number of steps. Notification of steps at the delivery address must be made when making the initial reservation or even more additional fees may be imposed.
- F) The Top Hat Party Rentals representative will provide verbal instructions with respect to the safe and proper operation of food concession equipment (i.e.; cotton candy, snow cone, popcorn, etc..). In some cases written instructions are also provided on the equipment. It is the Customer's responsibility to follow all verbal and written safety and operating instructions. If at any time the Customer is unsure how to operate the equipment , it will be the Customer's responsibility to contact Top Hat Party Rentals.
- G) With respect to table and chair rentals (all sizes and styles) it is the Lessee's responsibility to use the equipment properly. **DO NOT STAND ON ANY TABLES OR CHAIRS.** Tables and chairs are not to be used as step stools or ladders. Tables and chairs will collapse or break if they are not used properly.
- H) It is the Customer's responsibility to operate the helium tanks properly. The Top Hat Party Rentals representative will provide verbal instructions with respect to the safe and proper operation of the helium tanks. **HELIUM TANKS CAN CONTAIN HARMFUL, DANGEROUS AND FLAMMABLE SUBSTANCES. USE ONLY UNDER EXTREME CAUTION.**
- I) In the event that the Customer provides a generator as a power source for equipment rented from Top Hat Party Rentals, the following rules apply; the generator must supply a minimum of 3500 watts of power and have an attached fuel tank with a minimum 5 gallon capacity, the generator must be placed on a piece of plywood to protect the ground beneath it, no fewer then 4 orange caution cones or 12' of yellow caution tape must surround the generator, Customer agrees to comply with any other rules or regulations required by local Park Districts or Homeowners Associations.

- J) It is the Customer's responsibility to provide an adequate space to install the equipment and to provide an adequate power source. The Customer accepts responsibility for the location of the equipment. If the Customer or Top Hat Party Rentals representative do not accept the installation location, prior to set up, then the Rental Agreement will be terminated and no rental or other fees will be imposed.
- K) The Customer accepts the responsibility of protecting the equipment from water, pets and other hazards with the exception of natural weather conditions or a \$100 fee will be imposed on the customer, as well as, repair or replacement costs and loss of future Rental income while the equipment is being repaired or replaced. All repairs will be completed at a facility chosen by Top Hat Party Rentals.
- L) During periods of severe weather conditions (i.e., rain, high winds, etc.) we reserve the right to cancel your reservation at no charge. If severe weather conditions develop after the equipment is installed then Top Hat Party Rentals reserves the right to remove the equipment from the Delivery Address without providing any refunds.
- M) The Customer grants the Top Hat Party Rentals representative the right to re-enter the "Delivery Address" for subsequent pick-up of the equipment at the specified times. In the event that the equipment is not available for pick-up at the appointed time, a \$50.00 "Transportation Fee" shall be automatically imposed.
- N) With respect to the rental of tables, chairs, helium tanks, food concessions, etc. the Top Hat Party Rentals representative will drop off the equipment in one location at the Delivery Address. The equipment shall be available for pick up in the same location. Customer agrees to keep the equipment in his or her custody and not to sublease, rent, sell, remove from the Delivery Address, or otherwise transfer the equipment.
- O) In regards to "Disc Jockey Services"; A deposit and this signed agreement will be binding on both parties. The deposit is "Non-Refundable". The Top Hat Party Rentals representatives will make every reasonable effort to satisfy the Customer's request for music content. The Customer assumes full responsibility for his/her guests and agrees that Top Hat Party Rentals is not responsible for damage or injury resulting from the playback of recorded music.
